## ATTORNEY SPOTLIGHT:

*Karl W. Kristoff*



Karl has practiced law since 1968 and has been engaged almost exclusively in both school law and public sector labor relations work for more than 40 years. Karl has been designated by the New York State Commissioner of Education as a hearing officer for cases arising under Part 83 of the Commissioner's Regulations concerning teacher certification.

## The School Attorney

*Law Firms that represent School Districts are generally appointed at the Annual Reorganization meeting in July. School Districts may appoint more than one law firm to work with the district throughout the year. The Superintendent will generally have the most contact with the school attorneys in the course of a day. Key level administrators such as the School Business Official and the Director of Special Education may also be given authority by the Superintendent to contact the school attorney when issues arise within the school district. The school attorney works for the Board of Education. School districts will often have protocols, practices and policies in place for contacting the school attorney whereby the Board President is the designated individual who may contact the attorney on behalf of the Board of Education. Board of Education members need to realize that they as an individual Board Member may not have the authority to contact the school attorney.*

*Many of the law firms in the Buffalo area have either annual conferences or webinars available to their clients and potential clients. The seminars will help to educate Board Members and District Administrators on the latest and emerging issues in the area of Education Law. handling and arbitration, improper practice cases before the Public Employment Relations Board, public employee strikes and other job actions, certified and non-certified employee discipline and dismissal cases (including more than 50 cases under Section 3020-a), unemployment insurance and workers' compensation matters, and appeals to the Commissioner of Education and the courts.

Karl served on active duty with the U.S. Air Force as a judge advocate and special court military judge. Thereafter, he was appointed to various positions in the Air Force Reserve and Air National Guard of the United States, including staff judge advocate, assistant adjutant general, and commander for the headquarters, New York Air National Guard. He retired from his state service in 1999 with the rank of major general.

Karl has also served as an adjunct assistant professor in the University at Buffalo Graduate School of Education and at SUNY Buffalo Law School.

*representing the district with the particular issue. There are law conferences where their may be a charge to attend, or the workshop may be free. Programs may be in person, or they may be virtual where the participant can review the webinar or program later, so if a Board Member is unable to attend during the day, they can still take advantage of seminars. In addition school attorneys have often attended and presented at Board of Education retreats. The goal of any attorney or law firm is to keep the district out of court.*

## The Board & More Legal Issues

*A Board Member who violates his/her oath of office, the code of conduct or ethics or who engages in misconduct may be removed the Education Commissioner. Charges that have recently been filed against Board Members include:*

*- Unauthorized exercise of power by deliberately obstructing the board's recruitment of a superintendent; disclosure of confidential information from executive sessions, disclosure of students identification information, refusing to participate in and actively thwarting a board's investigation, disclosing confidential information, keeping confidential paperwork in executive session when instructed to return materials. The Commissioner further stipulated that the official misconduct charge under Education Law is not dependent upon a violation of statute or district policy.*
