Joe worked as a Special Assistant in the Attorney Generals' office.

In 2009, Mr. Giglio was appointed by the Governor as a member of the Public Authorities Control Board.

Additional appointments and acknowledgements included in 2008 when he received the Community Partners Award from the Cattaraugus County Council on Alcoholism & Substance Abuse and Friends and Family Award from Cattaraugus County Mental Health Association.
