QUESTION OF THE WEEK: Inquiring School Board Members want to know... "What are some ways that a School Board can prepare for a Superintendent Search?". School Boards can best prepare for the search by reaching out to the District Superintendent initially. They will help guide the School Board through a process. Schools can have the District Superintendent conduct the search, or they can reach out to a Search Consultant. It can be a lengthy process to conduct a Superintendent Search. Boards can prepare by attending conferences and workshops specifically designed to conducting Superintendent Searches, discussing amongst the Board Members the qualifications they are looking fo in a new superintendent, reviewing their mission statements and vision statements, determining what their short and long term goals are for the district and reaching out to the school employees and community. The search process should be fairly transparent so that all stake holders are aware of the process and the progress. ECASB has a few articles on hand that may be useful. Other resources include NYSSBA, The Western New York Leadership Group, The Western New York Educational Service Council and your school attorney.

Sophia is a social humanoid robot developed by the Hong Kong -based company Hanson Robotics. Sophia was activated on February 14, 2016, and made its first public appearance in mid-March 2016. United States. Sophia is marketed as a "social robot" that can mimic social behavior and induce feelings of love in humans. Sophia has been covered by media around the globe, and has participated in many high-profile interviews. In October 2017, Sophia was granted Saudi Arabian citizenship becoming the first robot to receive legal personhood in any country. According to founder David Hanson, Sophia's source code is about 70% open source.
