<u>QUESTION OF THE WEEK</u>: Inquiring School Board Members want to know... "Why does budgeting for Special Education become such a difficult issue?". School Boards can only budget for the current students that they have in the district. With current students, schools know the services that will be needed for the students. The difficult part is that schools do not know what students will be moving

into the district after the budget has been prepared. There could be Special Education students that have the need of specialized services and aides. The student might need a specialized program either at BOCES or another school that was never anticipated and accounted for in the budget. There could be one student that moves into the district, or there could be many students that move into the district that could affect the overall budget. Many districts will anticipate needs based on historical data. Legislation has been recently introduced in the Assembly (Assembly bill A02402) by Assemblymen Gigilio, Morinello and Norris that would allow schools to set up an Extraordinary Special Education Reserve. A companion bill in the Senate (Senate bill S00197) sponsored by Senators Gallivan and Borrello has also been introduced School districts should reach out to their legislators and urge them to support the bills.

# **NYSSBA AREA 1 DIRECTOR NEWS AND NOTES:**

In the past, at the NYSSBA convention, there were "presiders" at the various workshops. NYSSBA has eliminated the use of "presiders" for several reasons:

- The industry standard does not utilize presiders.
- With the use of presiders, the microphone would have to be wiped down each and everytime someone used the microphone to prevent the spread of COVID.
- Individuals that were scheduled to serve as presiders often times would not show up.
- By eliminating the presider, presenters are able to start right away with their presentation. They can introduce themselves through the presentation.
- Moving forward, NYSSBA may use "Room Attendants" to assist with taking attendance at sessions, and helping trouble shoot issues within the rooms.
